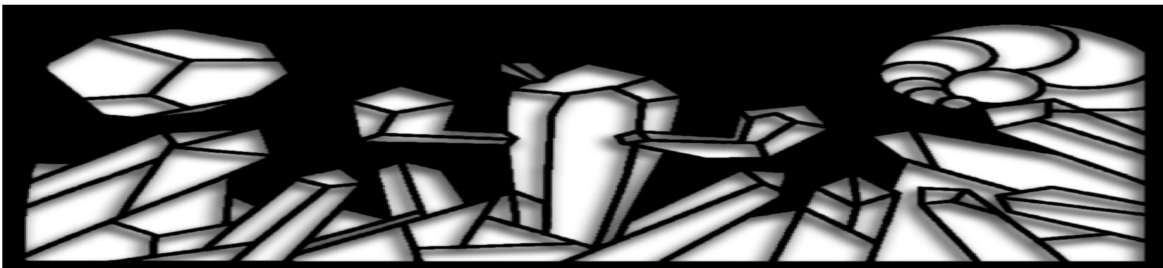

### PAYMENT SCHEDULE

- Payment is due upon delivery

### METHOD OF PAYMENT

- To qualify for tax exemption, please adhere to the laws and regulations set in place by local officials. Dynamic Events is not responsible for procuring this information.

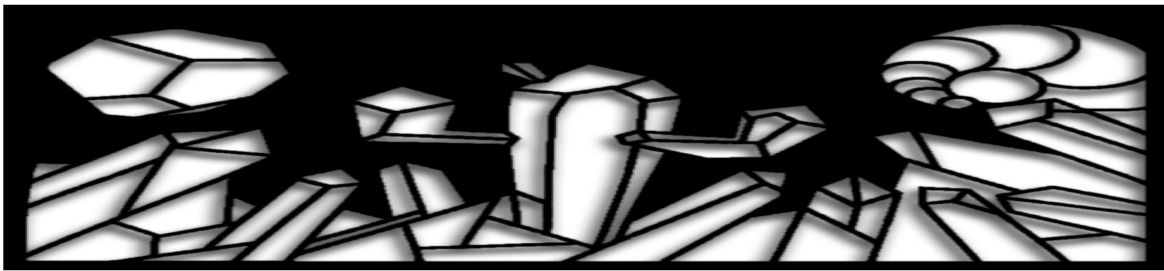
### EXHIBITOR SAFETY/ LIABILITY

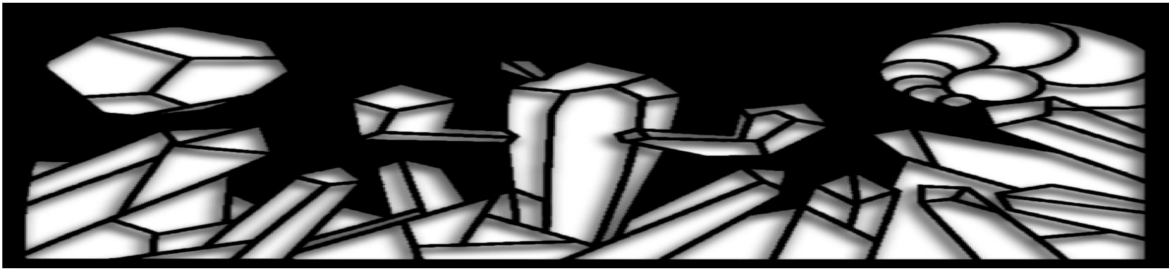

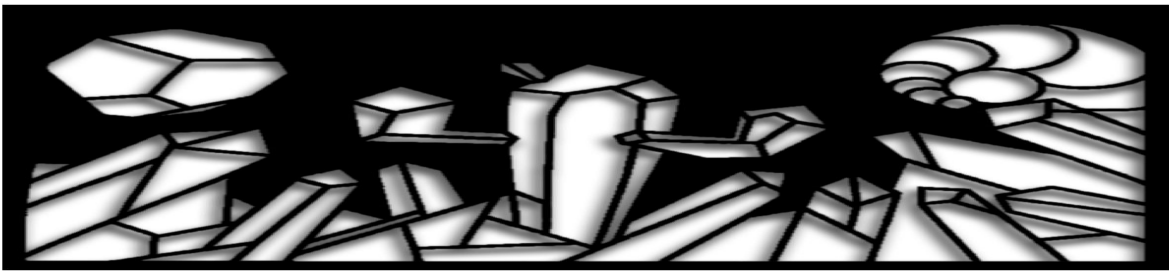

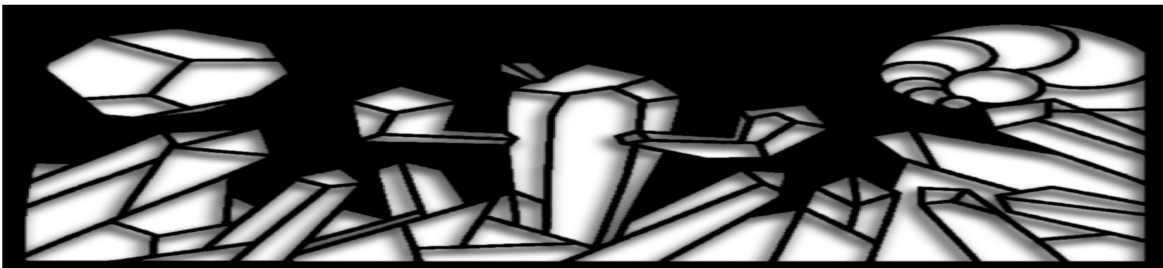
